- c) Applicants without Grade 12 Certificate, but who have experience in the industry will be considered based on experience (example Ambulance Drivers, First Aid providers, Volunteers, etc.). *A Class A First Aid certificate might be recommended*.
- d) Have no physical or mental impairment that would render them unable to perform all practical skills required for that level of certification.
- e) Have *no dependencies on drugs* (Cocaine, alcohol, opioids, or any other substance that may affect judgment, patient treatment and / or ability to function as a paramedic)
- f) Be physically fit and able to successfully pass a physical fitness test (on request) (include but not limited to shuttle run (Time dependant), push-ups, sit-ups, and body carry / pickup (Minimum of 50 Kg))

### EMERGENCY CARE PRACTITIONER COURSE TERMS AND CONDITIONS

- 1. A formal purchase order or proof of payment is required as acceptance of a quotation. No verbal acceptances will be used to book training.
- 2. Course bookings will only be made once a fully completed booking form has been received by EMTSS with proof of payment for the training as per payment agreement.

### **Emergency Management Training Course Outline**

## **EMERGENCY CARE PRACTITIONER – BASIC**

The Emergency Care Practitioner - Basic Course is designed to assess a patient's condition, and to perform such emergency medical procedures as are needed to maintain a patent airway with adequate breathing and cardiovascular circulation until the patient can be transferred to an appropriate destination for advanced medical care or advanced life support arrives on scene of the emergency. Interventions include cardiopulmonary resuscitation, External Automated Defibrillation, controlling severe external bleeding, preventing shock, body immobilization to prevent spinal damage, splinting of fractures, and assisting with childbirth. ECP - Basic are trained in basic life support. The course is presented towards the objectives to achieve a theoretical background (110 Hours) and practical application (50 Hours classroom skills). Assessment is done through theoretical and practical evaluation to test the competence in Cognitive and Psychomotor Domains.

Our Emergency Care Practitioner - Basic course covers the following topics:

### **Module 1 - Preparatory**

 Topics covered in this module are EMS systems, the role of the ECP-Basic, the safety and well-being of the ECP-Basic, legal and ethical issues, basic anatomy and physiology, techniques of lifting and moving patients.

#### **Module 2 - Airway Management**

• Topics covered in this module are airway anatomy, airway management techniques, oxygen, and oxygen equipment

#### **Module 3 - Patient Assessment**

• Topics covered in this module are assessment of the medical and trauma patients, vital sign assessment, taking a patient history, documentation, and communication

### **Module 4 - Medical Emergencies**

 Topics covered in this module are pharmacology, respiratory, cardiac, diabetic, allergy, poisoning and overdose, environmental, behavioural, obstetrical / gynaecological emergencies, geriatric emergencies.

#### Module 5 - Trauma Emergencies

• Topics covered in this module are bleeding and shock, soft tissue and musculoskeletal injuries, injuries to the head, neck, spine, chest, and abdomen.
